#### FACILITATOR REPORT JULY 28, 2019

Since our last meeting:

I completed the zonal recommendations of Danny and Biff to the HRP for positions on the World Board.

I met via zoom with the Admin Committee for the Southern Zone and the Delegates for the Lone Star Region so we could start the discussion on the joint, zonal CAR/CAT workshop in Dallas on January 24-26, 2020. We reached some preliminary decisions (subject to change):

- 1. The CAR/CAT workshops will be facilitated by the Zonal Facilitators.
- 2. If the CAT is released prior to the event, the focus of the event will be on the CAT with any remaining time devoted to the CAR. If the CAT is not released, then the entire weekend will be on the CAR.
- 3. Friday night CAR/CAT workshop will start around 6-7pm and go until 9-10pm. The Lone Star Region might also be having a PR event starting at 2-3pm. More will be revealed about that.
- 4. We would like to start the zonal meetings on Sunday as one combined meeting for the purpose of broadening perspectives by getting a better idea of what each of our zones do and how they do it. This will need the prior approval of each of the zones. We will each bring this up at our July 2019 zonal meetings. This is on the agenda for today's meeting.
- 5. The meeting room costs for the weekend is \$2,000. This is being paid for by the Lone Star Region and they are not asking for any reimbursement. I have placed on today's agenda a discussion on whether we want to reimburse their region for our portion of those meeting room costs.
- 6. An initial flyer for the weekend was created by the Lone Star Region and sent to all delegates in June. I will attach it to this report and include it in the minutes as well.

We should have our next zoom meeting with the Southern Zone sometime next month. One item I plan to discuss is having that CAR/CAT weekend made available to members of our zone via zoom.

At our last meeting, a proposal was adopted to have me contact the US Zones to see if they would be interested in a zoom meeting to begin the discussion on collaboration among US Zones. I would like to use some of the time we'll have with the Southern Zone to begin that discussion.

Greetings from the Florida Region. We continue to thrive and recover in the Florida Region. The Florida Region currently has 20 areas on the roll. Covering from Tallahassee eastward to Jacksonville south to Palm Beach and west to Sarasota including the island nations of Bermuda and Trinidad and Tobago with South Florida's Cental Florida Area tucked into the Greater Orlando area.

We elected a Regional Alternate Delegate at our May RSC and the recently elected AD sent a letter to the RSC on the Sunday of our regional meeting stating that he was not going to continue as AD and was officially stepping down. We made the body aware and we will have another AD election in September. More will be revealed...

Our Region has active Resource Coordinators with PR, H&I, Corrections and IT. Our PR folks have been busy with attending and participating in local conferences and are planning to attend FAADA. We have recently had a "changing of the guard" with the election cycle with our Resource Coordinator elections held in September. Joey is our H&I Resource Coordinator, Angelo is PR Resource Coordinator, Terri S, Alt PR, Ezra K is our IT Resource Coordinator and Colin H previous IT Resource Coordinator and all-around good egg is our newly elected Corrections Resource Coordinator. They are available and willing to assist any areas in the zone and beyond.

We would like to thank Biff for his service to the Florida Region for the last 4 years. His experience has been invaluable.

We just celebrated with our 38th Regional Convention "Shattering the Illusions" in Orlando. We were able to "Zoom" the main speaker meeting Saturday night. The FRC board is going to investigate also including the ASL interpreter in the Zoom meetings next year so we can offer the speaker meeting to our deaf addicts. For the first time the FRC board decided with the region's support to only offer Newcomer packages for people with under 30 days clean and we did not offer any indigent packages or donation in lieu of registration. We offered marathon meetings for all those who chose not to register. There were no newcomers turned away and any other situations were taken on a case by case basis. The board is discussing raising the newcomer threshold to 90 days and having a daily registration fee for all day Saturday.

FRC Inc has begun the planning for FRCNA 39 "Living the Dream" which will be held at the Rosen Shingle Creek in Orlando July 2th-5th 2020. We are currently looking for Convention and Pre-convention logo artwork. Anyone interested in submitting artwork, wanting to speak,

pre-register, or volunteer to do service at the convention can go to frcna.com. You can preregister for FRCNA 39 through the end of July 2019 for the bargain price of \$30.

Our RSO continues to be in a strong financial position even with the theft of 100k+ in funds. We are currently engaged in the legal process but understand the wheels of justice move very slowly. We were told that the former special worker (non-addict) could receive between 5-10 years in prison. Our fulltime special worker Barbara S. has resigned after 16+ years as our operations manager citing difficulty dealing with the RSO Vice-President and Office Manager. Attempts were made to mediate to try to find a workable solution but none was found. We thank Barbara S for her years of service/employment helping to make the Florida RSO a successful business. She will be missed. Our RSO staff flourished at FRCNA despite concerns as none of the current special workers had ever experienced the craziness of retail sales at FRCNA. Our RSO carries many interesting and special items. Please visit our RSO website at Floridarso.org and check out the neat things we have to offer like personalized recovery greeting cards and cute plush animals wearing NA hoodies. Many of you may have visited our on-site store at the FSS.

My region is still deadlocked on the Zonal BMLT decision. Our region chooses not to be linked in any way to meetings that use non-conference approved literature, they would however be amenable to joining the Zonal BMLT if the particular groups using non-conference approved literature where identified as such on the list.

### North Carolina Region Report to the SEZF July 28th, 2019 (Madison, AL)

9 areas, 154 groups, 356 meetings. We meet quarterly typical in Greensboro, NC. Our next RSC meeting will be August 10, 2019 at our 2nd annual compout, which will be held at Grandfather Mountain Campground in Banner Elk, NC.

The region has met once (4-27-19) since the zone last met in March in Tampa, FL.

The region formed an Adhoc Literature Translations Committee (or LTC) for the purposes of facilitating translation into Cherokee. We are working directly with NAWS and have completed a first pass of the glossary. We are in contact with Western North Carolina University for grammar review on the White Key Tag. Also our LTC is working with the Cherokee Language Consortium (Eastern and Western Band of Cherokee) to help develop new words that do not exist for some of the terminology in feeling and spirit of the NA language. IP#1 is actively being translated now.

Our regional phone line continues to operate well on Yap. We are seeing increased call volume overall on the North Carolina Statewide phonline. Many areas are starting to publish this number instead of their local number. Our projected cost for this year is about \$600, which is 750% savings since the project started. We will be proposing to move over to the zonal Yap server when our region meets next.

We visited the Carolina Region on April 13, 2019 to help propose the idea of a shared GSR assembly. The idea was well received, however we decided to go ahead with our assembly this year which was held on June 29, 2019. The regions shares an interest to work with the Carolina Region on something for the future.

One area in our region, The Greater Sandhills Area has reported that their convention committee has caused a rift in unity. Groups and services are struggling, because of the financial and human resources strain the convention creates. Many basic services like H&I and PR are not being delivered. Several of the members of this area showed up to the GSR Assembly and are now connected with the region. We hope to help provide support to them through our shared experience in whatever we can.

We moved our January meeting to February 1, 2020 to avoid date conflict with the SEZF meeting in Dallas. We also moved our April meeting to avoid date conflict with WSC2020. Our Regional CAT Assembly is scheduled for March 28, 2020 in Greensboro, NC. We plan to do online polling again for our group CAR tallies again this year and for the first time an online CAR workshop.

#### North Carolina Region Alternate Delegate Report

"GSR Assembly," was more of a regional assembly, held on a lovely summer day on Saturday 29 June 2019. We had participation from several of member areas: Crossroads, Greater Sandhills, Greensboro, Our Primary Purpose and a visitor from the NE part of NC. There were several other events held across the region on the same date. The morale raising, service oriented discussions included several World Service slideshows and some touching videos and melodies representing the diversity of our fellowship. There was an overview of the NC Region and the SE Zonal Forum (unfortunately this only included brief information on the task forces and Additional Needs). Lit Adhoc working on glossary and translating keytags, and literature, into Cherokee. Members staffed an informational booth at the inaugural NC Reentry conference and made many contacts.

Also, many thanks to the Additional Needs crew of the PR taskforce: we asked groups in the region to check the meeting schedules and make sure that correctly listed as wheelchair accessible. Some of the areas were also extremely appreciative of the information regarding members with service animals.

We spent some time discussing HnI efforts, accomplishments, and barriers that regions were experiencing.

Carolina Region: Sponsorship Behind the Walls project is up and running, looking for more involvement from members. Looking at the idea of getting a mobile HnI unit for far out and rural facilities. Some challenges with establishing communication with contact person at BOP facility. Brainstormed ideas to strengthen contacts. Has a monthly regional call to boost communication and involvement.

Georgia Region: Will have trainer from state prison system orient volunteers for HnI at the next regional meeting in December. They had this about a year ago. Seems to help to get folks approved, rather than dealing with local facility scheduling. Has monthly regional call to boost involvement and communication.

North Carolina Region: Discussing idea of implementing a monthly call, would like to sit in on the Georgia and Carolina HnI calls to learn. Participated in a Reentry Conference, membership staffed booth, made contacts with state prison administration and others. Some individual members have gotten involved in the sponsorship behind the walls Carolina Region project. We also have had some challenges with getting members approved for HnI and supporting home groups in prisons.

We discussed the purpose of Zonal Call to bring regions and area together to share successes and challenges with the purpose of better carrying the message into jails, prisons, and institutions where members can't get out to make local meetings. We'd like to do this every other month (months where NAWS HnI Call is not active). Any member is welcome regardless of subcommittee affiliation.

Next Call will be in October

PR task force has begun dwindling in numbers, still a good core of members but I'll be reaching out more and seeking new trusted servants as they switch over in the next couple months.

FSS additional needs workshop was a great success, we also reaffirmed additional needs as a project group going forward to create some best practices/guidelines. currently no other projects scheduled, just open sharing and discussion mostly.

#### BMLT SEZF Task Force, July 28, 2019

The SEZF BMLT Task Force is running strong with at least 5 active members communicating internally on the BMLT Slack Workspace.

#### Since we met in Florida:

- Exports from the BMLT Root Server were sent to NAWS at least monthly for Carolina, North Carolina, Georgia, and Alabama Northwest Florida regions, the most recent one being today.
- 2. Updated the zonal BMLT Root Server software 6 times, current version is 2.13.3.
- 3. Updated the zonal Yap installation for stability improvements and bug fixes.
- 4. Installed security updates on the server.
- Added the new West Georgia Area to the Root Server at the request of Jay H, representing PR for the Georgia Region.
- 6. At the request of the South Florida Region BMLT admin (Kevin D):
  - Reset a password for the Mid-Coast Area
  - Granted the South Florida Service Body Admin user the ability to reset its member area user passwords.
- 7.
  The South Florida Region BMLT admin noticed a bug in the root server software where the wrong Service Body could be displayed in the "Service Body Administration" portion of the admin UI. We fixed this bug in the root server software, cut an official BMLT Root Server release, and upgraded to resolve the issue.

RDs, ADS, RCMS, PR Chairs: We request this information as soon as possible. A suggestion would be that Areas could ask a show of hands from GSRs if there is any member fitting the request in their group. GSRs would be knowledgeable if there were such a member attending their group. If a GSR does not know, or does not answer, it will be fine to mark it down as a "no" from that group.

This information will be used twofold:

- 1) As part of the presentation for the Florida Symposium
- 2) As the basis of the Additional Needs Workgroup creating guidelines on Outreach and how NA group members can reach out to newcomers and other members with these additional challenges.

Disclaimer: Narcotics Anonymous does not enforce the law. This listing of the law, and the consequences for groups not complying with the law, are included so that your group can make a fully informed choice. This is in line with Chapter 4 in the Basic Text: "We believe that the sooner we face our problems within our society, in everyday living, just that much faster do we become acceptable, responsible and productive members of that society". Additionally, Narcotics Anonymous supports the right of every addict to find recovery through Narcotics Anonymous. To assist Groups and the NA service Structure to fulfill Tradition 3 and Tradition 5 in reaching out to those with Additional Needs, the following guidelines are being provided. This guideline is only a general guidance on a complex set of issues. Groups and Service Entities may find that their situation may not be covered in these guidelines. In these cases, or at any time, it is highly encouraged to contact your Area, Region, SFRSC Public Relations Additional Needs Point of Contact (POC) or NAWS to obtain further assistance.

Statement of Purpose: The South Florida Regional Public Relations is committed to supporting the right of every addict to find recovery through Narcotics Anonymous. This guideline is to help groups, Areas Region and Conventions with suggestions on what to do when faced with accessibility issues about addicts with physical, visual and hearing disabilities. This guideline will address those with hearing disabilities at meetings.

#### Definitions of Hearing Impairment:

- 1) Deaf: Significant or profound hearing loss. The method of communication is primarily American Sign Language (ASL).
- 2) Hard of Hearing: Any degree of hearing loss without the use of ASL. Depending on the degree of hearing loss, the use of hearing aids, apps and special devices and lip reading may be used.

In both groups, the level of verbal or written English skills may vary widely.

How to assist a NA member with a hearing disability at a meeting:

It can be difficult to tell if a member has a hearing disability. Hopefully, the member will let someone know of any needs. If there is an initial difficulty in communicating, pen and paper, or cell texting, may be an option.

No matter what degree of hearing impairment, the following information will help:

1) Insure to maintain eye contact. When one looks away while speaking, or covers the mouth, it becomes difficult to read facial and body expressions and lips.

- 2) Do not speak loudly or not at all. Speaking louder will rarely help (unless the member states that it will) and not speaking at all would be just as rude as not speaking to any other newcomer.
- 3) One person speaks at a time. It is very difficult to understand several people speaking. This is because the hearing-impaired member is also looking at facial and body expressions. Trying to watch several people at a time not only is challenging but causes a loss of communication.
- 4) Meeting chair arrangement and seating are also important. Chairs arranged in a circle, square or rectangle are optimal. When chairs are in a row, for example many speaker meetings, insure the hearing-impaired person has a seat up front with unrestricted view of the speaker.
- 5) Maintaining an atmosphere of recovery in the meeting also helps. Members need to keep in mind that when they continually get up and down from their seats, especially in front of the hearing-impaired member, that valuable communication is lost. Also, cross talk also interrupts communication, as well as the meeting.
- 6) Lighting: Lighting is important for the member to be able to read lips and see the speaker and interpreter. A special situation is candlelight meetings. If the meeting is a candlelight meeting, on the meeting schedule and candlelight stated in the format, there is no need to turn on the lights. There is always a place at the meeting where the member and the interpreter can be seated where it does not interfere with the candlelight format but offers the ability to the member to see the interpreter. Spirituality and common sense will help find a solution.
- 7) During the readings, offer the written literature for the member to read and follow along.

If the member states that the preferred method of communication is ASL, a certified Sign Language interpreter should be utilized.

Obtaining an interpreter can be done by contacting the state registry of certified interpreters or an interpreting agency. Certified interpreters are bound by a Code of Ethics and must adhere to HIPAA (the laws that govern medical release of information and confidentiality). Therefore, even in a closed meeting, anonymity will be kept.

Many groups will be concerned about cost. Here are some suggestions to help:

1) Friends or family members interpreting: there are some draw backs to this. If a family member is interpreting, the NA member may not be able to speak freely (this would be the same as having your mom in the room). Additionally, they might not understand NA terms and relay the information incorrectly. This would also apply to a friend who is not a NA member.

- 2) A NA member that knows ASL: this can be a good option if the meeting does not overburden the NA member doing sign. Remember, that NA member also deserves meetings where she or he can concentrate on the meeting for themselves. When someone is interpreting, their focus is on their task and they may not get the life saving message of NA that they need for themselves.
- 3) Interpreters needing CEU (hours for certification) may be willing to interpret one regularly scheduled meeting a week for a very nominal fee.
- 4) If there are 2 neighboring Areas that have members needing an interpreter, those Areas can choose a meeting near their boundary and share the cost of the interpreter. Group member should ensure that the hearing impaired members have transportation to that meeting.
- 5) Court and treatment ordered members: In most states, Florida included, when a member requires an interpreter, the COURT or the TREATMENT CENTER must provide the interpreter. Remind the member that she or he has that right. If the member sticks and stays after court/treatment orders, THEN it will be the responsibility of the group to obtain the interpreter.
- 6) There is special equipment, both apps and instruments, that can assist in interpreting. Some members may have access to this, and others may not. It may be brought to the service system (Area, Region) if purchasing one-time equipment may be an option.
- 7) Another medium available is the virtual meeting Deaf Zoom group. This group meetings on Zoom on Thursday 8 pm EST and Saturday 12 noon EST. This is a closed group has both ASL and voice and welcomes any addict. This group is not to be used in place of physical meetings but is a welcome aid to recovery. - 8) The website should have instructions for those that are hearing impaired to be able to use the phone lines. Phones lines that are able to receive texts will also help.

Please remember that members with Additional Needs are full NA members. Including them in business meetings, service work and activities allows them to feel a part of the group and NA, rather than apart from everyone.

#### Carolina Region's questions and concerns

#### **New Business**

Regarding the email sent out about the reimbursement of the SZ: When the proposal was presented by the Southern Zone to go to Texas, it stated that the only cost would be food, lodging and travel for each region's RD/AD and the facilitator and secretary/treasurer of the SEZF. The CRNA is asking for clarification on an additional reimbursement to the SZ mentioned in the email. What is it for and what is the amount?

The CRSC Policy Committee saw the SEZF Articles of Incorporation on SUNBIZ. Article 4 directed us to see the By-Laws for an explanation of how the directors are elected or appointed, etc. Where are the SEZF By-Laws? The CRSC is requesting a copy for their records.

#### **Old Business**

#### **Local Support Service**

- Why start a new task force? Why do we need a Fellowship Development Task Force? (It seems like the SEZF already performs these functions.)
- Can the Additional Needs workgroup be its own entity? Why should it go from under the PR
  task force umbrella to the Local Support Services umbrella? This is a service to all members and
  the Areas, Regions and Zones.

#### **SEZF Budget Concerns:**

- In the budget there was a \$2000.00 amount for special events. However, nothing explains what is considered a special event. Also, who can bring an event to the SEZF? Regions in our Zone? Regions in other zones? Other Zones? Please Specify.
- The Facilitator and Secretary/Treasurer have a food per diem. Is the per diem based on the federal rate or is it a set amount? Please specify.
- If the SEZF budget doesn't pass, how does the SEZF approve funding (for Zoom, Facilitator, Secretary/Treasurer, meeting locations, etc.)? What is the process/procedure?
- What is the procedure for the accounting of non-budgeted items? What is the limit of the amount where a proposal is to be sent back to the Regions for a vote?

#### **SEZF Guidelines/Policy Concerns:**

- 1. Who is the voting body at the SEZF? This is not specified. I.E. "One vote per region."
- 2. Why isn't there a chain of command specified in the SEZF Guidelines?
- 3. What is quorum? Is there a quorum at the SEZF? If not, why not? What is the voting process? What are the parameters to fail or pass proposals?
- 4. How are proposals submitted? By whom should they be submitted? Regions in our Zone? Regions from other Zones? Other Zones?
- 5. Members of our Region are suggesting that we have consistency by requiring an 80% approval vote for all items in the SEZF Guidelines. The only exception are the changes to the SEZF Guidelines themselves which require that any and all changes be sent back to the Regions for approval by only a unanimous vote
- 6. When can the SEZF guidelines/policy be set aside? And is a unanimous vote required?

- What is the difference between a Task Force, a Work Group, an Ad-Hoc Committee, and a regular Committee? Members of our Region feel there should be something in the SEZF Guideline differentiating them.
- 8. What is the beginning and ending of the SEZF fiscal year?
- 9. Why aren't there any practices or procedures specified for financials in the SEZF Guidelines? In addition, the following issues should be addressed:
  - Who are the signers on the bank account?
  - Who reconciles the bank account? (This should be someone other than a signer on the account.)
  - When is the budget sent out to be voted on, month year? Should there be a designated Zoom meeting to discuss questions about the budget before the SEZF?

#### **Additional Questions from the CRSC:**

- How may a Region join the SEZF? If another Region joins, would that add another SEZF meeting? If so, would it be a face to face meeting or a Zoom meeting? Would the donation change? When would they be added to the rotation? Please specify.
- Why isn't there an RD as Co-Facilitator or Alternate Secretary/Treasurer? (This would be to
  assist in an emergency or during SEZF meetings and would allow for someone to take minutes
  and facilitate the meetings.)
- The SEZF Zoom account who is the registered account holder for the SEZF Zoom account? Who
  updates the account? Who may use this account? Is it only the SEZF and the Regions that form
  the SEZF? May other Zones or Regions use the Zoom account with permission from the voting
  body, or from one Regions RD or AD? Please specify.
